Definitions and interpretation

- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;

d. "including" is understood to mean "including without limitation"; reference to any statutory provision includes any modification or amendment of it; the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Neurosight Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Neurosight Ltd is the "data controller". This means that Neurosight Ltd determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data from you should you complete an online assessment, this is usually limited to:
 - a. name;

 - f. data related to your interaction with and navigation of the assessment interface;

in each case, in accordance with this privacy policy.

We collect this data to provide a fair, effective assessment experience. The information helps us validate the integrity of the assessment process, enhance our scoring algorithms, and ensure the reliability of results. Data about your web browser type and operating system helps us optimise our platform's compatibility and functionality. All data collection and processing is conducted in accordance with this privacy policy, and the relevant data protection and privacy regulations. This data is anonymised and encrypted to maintain the highest level of data privacy and security.

How we collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you; and
 - b. data is collected automatically.

Data that is given to us by you

- 7. Neurosight Ltd will collect your Data in a number of ways, for example:
 - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - b. when you register with us and set up an account to use our products/services;
 - c. when you complete assessments that we use for research purposes;
 - d. when you use our services as a direct customer or as a participant in an online assessment;

in each case, in accordance with this privacy policy.

Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and allows us to deliver effective online assessments that account for your particular browser and operating system
 - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
 - a. internal record keeping;
 - b. improvement of our products / services;
 - c. analysis of the effectiveness and fairness of our online assessments;

in each case, in accordance with this privacy policy.

- 10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
- 11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

Who we share Data with

- 12. We may share your Data with the following groups of people for the following reasons:
 - a. our employees, agents and/or professional advisors to permit validation analysis and ensure the effectiveness and fairness of our assessments;

in each case, in accordance with this privacy policy.

Keeping Data secure

- 13. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.

Data retention

Your rights

- 19. You have the following rights in relation to your Data:
